The Participant understands that camp activities include constructing and fabricating structures. The Participant hereby freely, voluntarily, and without duress executes this release under the following terms:

Release and Waiver: Participant does hereby release and forever discharge and hold harmless Bridge of Grace and its successors and assigns any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Participant's activities with Bridge of Grace.

Participant understands that this release discharges Bridge of Grace from any liability or claim that the Participant may have against Bridge of Grace with respect to any bodily injury, personal injury, illness, death or property damage that may result from Participant's Activities with Bridge of Grace, whether caused by the negligence of Bridge of Grace or its officers, directors, employees, agents or otherwise. Participant also understands that Bridge of Grace does not assume any responsibility for, or obligation to, provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

Assumption of the Risk: The Participant understands that activities include tasks, activities or work that may be hazardous to the Participant, including, but not limited to, construction, fabrication, loading and unloading heavy equipment and materials, using tools (including power tools) and transportation to and from Activity/Event sites.

Participant hereby expressly and specifically assume the risk of injury or harm in the activities/events and releases Bridge of Grace from all liability for injury, illness, death, or property damage resulting from the activities/events.

Other: Participant expressly agrees that this release is intended to be as broad and inclusive as permitted by the laws of the State Indiana, and that this release shall be governed by, and interpreted in accordance with the law of the State of Indiana. Participant agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provision of this Release which shall continue to be enforceable.
